**NPI PARTNER ACCEPTANCE OF NPI'S PARTNER PROGRAM FOR ADT COMPANION SERVICES®**

**NPI GOLD PROVIDER:** FULL SERVICE PROGRAM – NPI PARTNER INVENTORIES PRODUCT, COMPLETES THE CUSTOMER PROFILE & ENTERS THE CUSTOMER INFORMATION ON THE ADTCOMPANION.COM WEB SITE, INSTALLS & ACTIVATES THE SYSTEM (CUSTOMER DIRECTLY PAYS NPI PARTNER FOR THIS SERVICE), SENDS THE ADMINISTRATION PROFILE COPY TO ADT ([ADT Security Services, Inc., ADT HHSS – Kim McCollough, 14200 E. Exposition Ave, Aurora, CO 80012](#)), AND ASSUMES A 30-DAY CUSTOMER SERVICE RESPONSIBILITY. THE SUGGESTED INSTALLATION FEE FOR COMPANION SERVICES IS BETWEEN \$49-\$99. THE GOLD NPI PARTNER RECEIVES A ONE TIME REVENUE SHARE OF **4 x MRR** (MONTHLY RECURRING REVENUE) FOR COMPANION SERVICES, OR OPTIONALLY ELEVEN (11) PERCENT OF THE MRR PER MONTH, AND IS PAID DIRECTLY BY ADT ON BEHALF OF NPI.
