NPI COMMUNITY PARTNER ACCEPTANCE OF APPOINTMENT AS A NPI – TSI - XANBOO AUTHORIZED CONSULTANT

_____ (LEGALLY INCORPORATED NAME – “ENTITY”) HAS REVIEWED THE NPI - XANBOO PROGRAM AND AGREES TO BECOME A NPI AUTHORIZED CONSULTANT PROVIDING TSI – XANBOO HOME AND BUSINESS SECURITY SYSTEMS.

“ENTITY” AGREES TO IMPLEMENT THE FOLLOWING PROGRAM REQUIREMENTS:

- “ENTITY” will market the product.
- “ENTITY” will assist customers to place orders via the NPI – Xanboo online store. “ENTITY” will receive a Consultant ID number. **NO COMMISSIONS OR MONTHLY RESIDUAL PAYMENTS WILL BE MADE ON SALES THAT DO NOT CONTAIN A CONSULTANT ID NUMBER.**
- The Product will be shipped directly to the customer for self installation.
- “ENTITY” will be notified of the UPS delivery schedule.
- “ENTITY” may charge an installation fee if the customer needs someone to install the system.
- “ENTITY” will be paid both weekly commissions and a monthly revenue share:
Equipment Sales Commission – 15% of the retail price. Monthly Revenue Share/Residuals - 30% of total **active** subscriber fees.

“ENTITY” agrees to the NPI Partner Program requirements for TSI – Xanboo as stated above, and understands that “ENTITY” will be assigned a NPI – Xanboo Distributor ID Number to carry out the above obligations. “ENTITY” agrees to complete & sign a TSI W-9 Form upon Program activation. “ENTITY” also agrees to accept TSI’S related Technical & Marketing Program Training, and represent and promote NPI – Xanboo or other TSI products that the “ENTITY” is comfortable with in its service area. “ENTITY” agrees that it is solely and exclusively an authorized Consultant for NPI pursuant to this NPI Consultant Agreement executed between NPI and “ENTITY”. “ENTITY” agrees to assume toward NPI all of NPI’s obligations and duties which NPI, pursuant to NPI’s Authorized Dealer Agreement with TSI – Xanboo. However, “ENTITY” agrees that it is not a party to, nor an expressed or implied third party beneficiary of NPI’s Authorized Dealer Agreement with TSI, and “ENTITY” agrees that it has no contractual relationship with TSI nor any rights, remedies, or redress against TSI.
